


Survival Member Certificate

The loss of a loved one is difficult for everyone. However, the family will face greater challenges in getting the benefits and investments on behalf of the deceased person. A survival Member Certificate can be an excellent tool for the family members to benefit for the deceased or the family member who is presenting the benefits on behalf of him. It is the sole and easily accessible tool that can be used to obtain an acknowledgement by the authorities in charge of the person who is alive following the death. The certificate can be easily obtained by contacting the Sub-District Magistrate's Office with a minimum of documents from the person who is the last member of the family members of the deceased via an online procedure.

Certain Benefits of Survival Member Certificates:

- 1. This document helps establish a direct connection between the family and the decedent person.
- 2. Aids in the transfer and claim of rights to movable and immovable assets and insurance rights of the deceased.
- 3. The survival member certificate allows you to families get pensions, a gratuity, provident fund as well as other benefits from the government.
- 4. Connection to electricity, phone and the transfer of property can be completed quickly by the relative of the deceased.



5. This certificate also assists in claiming rights to ancestral property from the legal heirs in accordance with the Hindu Succession Act. This law can be triggered when a family member passes away without leaving a legacy in the wake. Any surviving family member is able to approach the government. Authority to issue the certificate of surviving member or legal heirship certificate.

Members that fall under "legal heirs" include;

- 1. Class 1 Legal Heirs The Surviving Spouse or Daughter Son Mother, and Surviving Spouse.
- 2. If you don't have Class 1 Legal Heirs: Parents and siblings.

Eligibility Criteria to fill out the application form for Survival Member Certificate in Delhi are

- 1. The person must be a citizen of India.
- 2. The individual is resident of Delhi.

Instructions and documents to fill in an application online at an office for the Sub-District Magistrate in one district within Delhi's National Capital Territory of Delhi;

Documents are required

- 1. A copy of the original Death Certificate issued by the the deceased person who has been notified by an Govt Authority.
- 2. Photocopy of Identity Proof and Address Proof of Person Deceased.
- 3. For the sole purpose of obtaining the legal heir certificate the family has to submit an undertaking affidavit from each survivor of the deceased's family and the person applying for it.
- 4. Passport Size Photographs of each applicant and their surviving family member.
- 5. Address and ID Proof of the surviving family member and the applicant.

The applicant can submit an online application with great ease using the procedure below.--

- 1. Applicant easily searches the website www.district.delhigovt.nic.in and registers himself as a new user with his Identity Proof and validates the details with a one-time password by the district Delhi website on registered Mobile No.
- 2. Log in to your account and choose the application form that says "Issuance of Survival Member Certificate". Fill in all the mandatory information and upload a scan copy of all original documents. When you've completed the form in a timely manner, acknowledgement is created.



- 3. Print a acknowledgement in its entirety and include all original photocopies along with it. keeping the originals with you to verify the papers at the SDM office.
- 4. Form filling and verification procedure completed after proper verification for Data The Certificate is issued on the internet. With the Acknowledgment number. the applicant is able to access an electronic copy of the Survival Member Certificate.

The processes and the documents are basic. It is possible to avail these kinds of services from the government however, due to a ignorance the family members will have to face numerous challenges to receive the benefits.
